Response to Australia's Inaugural Social Cohesion Statement (the Statement)

AMES Australia Knowledge Centre April 30, 2021

AMES Australia (AMES) acknowledges the importance of having a Social Cohesion statement and welcomes the obvious commitment of government to social cohesion and multiculturalism. We take this opportunity to further contribute to providing input into the inaugural Social Cohesion Statement. As a starting point AMES considers that:

- 1. the **context** for the Statement needs to be clearly articulated including understanding the purpose, who the Statement is targeting, and how the Statement is to be implemented and measured/judged as successful or impactful.
- 2. the Statement needs to be **simplified** this will have greater potential to resonate with, and engage, the target audience/s.
- 3. the language of the Statement must foster inclusiveness.

AMES work is guided by our vision of 'full participation for all in a cohesive and diverse society' and is focused on maximising the economic and social participation of migrants, refugees and asylum seekers and promoting and celebrating the benefits of migration to Australia.

The following core principles which inform our vision, reflect our value proposition, and underpin social cohesion may provide a further or different lens for framing the Statement:

- Value the key underpinnings of a liberal democracy freedom, equal opportunity, individual rights and responsibilities together with valuing mutual respect, tolerance and diversity.
- Respect Australia's first peoples and acknowledge that Australia is their homeland.
- Create environments that are safe, secure and cohesive, that address discrimination, promote gender equity and respect the rights of children.
- Create environments that support every individual to reach their full potential.
- Increase economic inclusion for all through equal access to skills development, education and training, work opportunities and fair pay.
- Promote a shared means of communication to connect and engage people and communities and facilitate social participation, connection, and inclusion.

Within this context the following table responds to each section of the draft Statement; provides a comment on the section; and offers alternative wording aligned to each section for consideration.

Propose emphasis on people rather than the abstract concept of place/geography.	Cohesion begins in our communities – Social cohesion is about working together to support equal opportunity for every individual to reach their full potential, reducing disparities in social and economic outcomes for all Australians and contributing to individual wellbeing, strong communities, a stable society and our economic prosperity.
A culturally and religiously diverse nation – Our inclusive national identity welcomes peoples of all cultures and religions. Within the overarching framework of Australia's democracy and laws, our multicultural and multifaith society is a strength and supports our vibrant society and economic prosperity.	Religion is one aspect of culture. Having no faith does not lessen a person's value in society. Australian citizenship is our common bond – Citizenship is a core element of our national identity and democracy. Whether acquired at birth or as a new citizen - Australian citizenship represents full and formal membership of the Australian community. We value the rights and responsibilities of Citizenship.	Australian citizenship is not available to all and others do not seek formal citizenship status. Propose removing 'Australian citizenship is our common bond ' and replace with eg. Australia's national identity is built on democracy, respect for diversity, rights and responsibilities	NB: this alternative wording from the first section also covers this section - therefore reducing the overall words and potentially making this redundant. Australia is a prosperous and safe multicultural country. Australia's national identity is built around core civic values of democracy, freedom, equal opportunity, the rule of law, individual rights and responsibilities. We value mutual respect, tolerance and diversity that contribute to a strong, cohesive and resilient society.
The English language as a unifying force – English language proficiency is a key contributor to better education and employment outcomes and social participation levels. It helps to provide an overall sense of belonging, and knowledge of English provides access to a diversity of news and information sources.	Propose that this statement be rethought. As currently written, it represents a narrowness and exclusivity that may undermine diversity.	English is our national language. A shared means of communicating promotes shared understanding of community values, connects diverse cultures and facilitates the social and economic participation of all who live in our community.
